Hello fellow CDS members! I'd like to give you information about the Presbyterian Medical (also dental) Clinic in Patchakan, Belize. We first became aware of this mission opportunity at a CDS Family Conference in 1999. We went there on our first-ever mission trip as a family in 2000 and have fallen in love with the people and ministry. For the last several years my niece, a hygienist, has come along and been greatly appreciated by us and the patients!

There is an established, full-time, medical clinic with a newly air-conditioned dental room available for visiting dental professionals. There are two dental chairs with working units providing handpieces, air/water syringe, and suction. An autoclave is also present and working.

The clinic has a full-time, national chaplain who shares the gospel with all medical and dental patients while they are waiting for their pre-scheduled appointments. The staff at the clinic are very welcoming and helpful. A translator is available as needed. Housing is provided on site with clean accommodations and heated water for showers.

This is an opportunity for someone to have a relatively comfortable first exposure to missions as a single, couple, or family, or for mission veterans who want short flights for a change. Over the last 20 years, God has used this ministry to deepen our personal walks with Him as we have had the opportunity to share His love with the people of Belize!
